The above mentioned parties agree as follows:

- Triple T Outfitting agree to provide:
 - Camp facilities consisting of lodge, bunkrooms and/or cabin and adequate food;
 - Adequate transportation when necessary for hunting, from established camps for use by hunter and his guide;
 - A licensed guide who shall work with the hunter;
 - Field care of animals (skinning and salting) caping and processing extra.
- Hunter/client agrees to pay the outfitter for the services mentioned, the sum of (U.S. dollars) _____ cost of the hunt; with a deposit paid upon booking the hunt, _____ balance due upon arrival at our lodge.

- Terms: (please read carefully)
- All final payments to Outfitter, cash, bankdraft, or travelers checks.
 - Outfitters will concentrate on your primary animal listed; once taken, then offer birds and varmint hunting. However the numbers and availability of birds depends on spring hatching conditions. When hunting birds hunter may be hunting more than 2 on 1, outfitter may also direct hunter to bird areas to hunt on his/her own as guides may be needed to fill primary animals.
 - Deposits are not refundable once license is received. However the hunter may carry the deposit forward one year.
 - Exceptions: cancellation due to death or hospitalization (doctor certification needed).
 - Outfitter fees DO NOT INCLUDE: A) cost of transportation to or from hunters' home to or from base camp; B) Shipping of trophy to hunter or taxidermist; C) Shipping of frozen meat to hunter; D) Processing of game animals or caping; E) Hunting license.
 - Client is responsible for all his or her own clothing, firearms and personal belongings. Outfitter is not responsible for any damage or loss to Client's property. Client will obey all Montana and federal hunting and fishing laws and regulations and all instructions of Outfitter, all guides and employees. Client will reimburse Outfitter for all costs or fines resulting from Client's violation of any Montana or federal law or regulation. Outfitter may terminate this Agreement for any violation without refund.
 - Client has received, read and understands the "Release and Waiver of Liability" attached to this Agreement. This Agreement incorporates the Waiver.

RELEASE AND WAIVER OF LIABILITY

The undersigned recognizes that there is a significant element of risk in any hunting activity associated with the outdoors, such as horseback riding, hunting, fishing, rafting, and other recreational activities. Knowing the inherent risks, dangers and rigors involved in the activities, I certify that my family and I, including and minor children, are fully capable of participating in the activities, and accept the risk involved.

I accept full responsibility for my family and myself, including any minor children, for bodily injury, death, loss of personal property and expense thereof, as a result of my negligence or the negligence of my family. The undersigned does further release and forever discharge and agrees to hold harmless, Triple T Outfitting, its officers and employees and agents, and its heirs, successors and assigns, for and from all manner of actions, suits, losses, and claims and demands of any nature arising out of or connected with this Agreement resulting or to result from any accident which may occur as a result of my participation in hunting and recreational activities hereunder.

I further understand the outfitter reserves the right to refuse any person he judges to be incapable of meeting the rigors and requirements of participating in the activities.

I have read, and understand and accept the terms and conditions stated herein and acknowledge that this Agreement shall be effective and binding upon us during the entire period of participation in the activities.
